1. Bodnik Bows guarantee is not limited by the arrow weight gpi.  
(gpi = grains per inch)
2. Bodnik Bows guarantee stays in effect even if you resell your bow
3. Bodnik Bows guarantee is active for a full 30- years
4. Henry Bodnik and the bowyers at Bodnik Bows personally back and support this guarantee.

## THE WARRANTY COVERS

1. Broken limbs;
2. Delamination of limbs;
3. Cracks in limbs and limb laminations;
4. Broken risers;
5. Cracks in risers;
6. Broken bow tips or bow tip overlays.

## WARRANTY EXCLUSIONS

1. Any twisting of the limbs that occurs after 6 months of purchasing the bow from Bodnik Bows;
2. Repairs and obvious signs of wear;
3. Visual objections to the clarity of the glass.

## IMMEDIATE NEGATING OF THE WARRANTY

1. Any drilling, grinding, or filing done to the bow which was not performed by Bodnik Bows
2. Any grossly negligent or willful destruction or damage caused to the bow Guarantee.

## GUARANTEE

- ° Bodnik Bows may elect to make repairs to your bow
- ° Bodnik Bows may decide to exchange of the bow for either an identical model or an equivalent bow model (If the same bow model is no longer built).

### **How to process the Bodnik Bows 30-Year Warranty**

The customer has to provide detailed pics of the warranty claim like described below. We will try to decide the warranty claim based on the information and pics provided by the customer. If the warranty claim can not be decided clearly, the customer has to send the bow back to his dealer or Bodnik Bows.

Bodnik Bows will repair or replace the bow. If the bow is not any more in production or wood choices have been changed, Bodnik Bows will replace the bow with the actual model in the same price range.

### **Required images**

1. pic: Close up of the damage
2. pic: Complete bow including damage
3. pic: Bodnik Bow serial no incl. riser

### **Shipping process**

- The customer bears the shipping costs for sending the bow back to his dealer or Bodnik Bows.
- The Bodnik Bows dealer bears the shipping cost sending the bow back to Bodnik Bows
- Bodnik Bows bears the shipping cost for sending the bow back to the customer or the bodnik bows dealer.
